Generous Benefactor, Elwood S. Kendrick, Passes Away Leaving his Legacy at Illinois

Born on April 15, 1912 in Warwick, North Dakota, Elwood graduated from his home institution of North Dakota State University prior to coming to the University of Illinois College of Law where he graduated in the Class of 1937. His career as a lawyer and a philanthropist in the 70 years following law school is a story very few can match.

Elwood began his career as counsel for Shell Development in San Francisco, later joining the U.S. Department of Justice as a special attorney in its antitrust division. After working as a patent lawyer in the U.S. Army Corps of Engineers, which assigned him to the Manhattan Project, Elwood founded his own law practice sharing offices with prominent antitrust lawyer and later S.F. Mayor Joseph L. Alioto. Elwood worked with Alioto on the brief for the U.S. Supreme Court case of *Radovich v. National Football League*, which held that professional football was not exempt from federal antitrust law. The core of Elwood's practice for the next 55 years would be as a leader in the field of patents, trademarks and copyright – both domestically and internationally.

As impressive as his legal career had been, so was the time and effort Elwood devoted to his alma mater. For decades, Elwood played a leadership volunteer and donor role at the College of Law, most notably as a founding member of the John E. Cribbet Society and a lead contributor of the Alumni Distinguished Professorship of Law. As a volunteer, Elwood devoted his energies to the College's Board of Visitors and as a campaign volunteer in the 1980s. He was honored with the College's prestigious Distinguished Alumnus Award in 1981.

Elwood's generosity did not end with his recent passing. Through an estate bequest, Elwood provided a \$100,000 gift to the Law School Annual Fund, which is being used to fund faculty programs and student scholarships. This level of current-use estate contribution is significant because it provides the College the equivalent spending power as a \$2 million endowment.

Elwood's wit, character, and ability to tell wonderful stories entertained the faculty, staff and students at the College of Law for the past six decades, now his philanthropic legacy will benefit the College for many years to come.

Frank A. Reichelderfer 1919 – 2007

Frank A. Reichelderfer graduated from the University of Illinois College of Business in Accountancy in 1940 and from the College of Law in 1943. Frank graduated with Honors and was in the Order of the Coif. It was a War year and the school drifted down in numbers until the whole Law School had fewer than 100 students. Much of the faculty was teaching only part time. One of those was Bill Britton, the authority on Oil and Gas Law. He encouraged Frank to go to Chicago and to join the law firm of Wilson & McIlvaine, where Bill practiced when he was not teaching. Frank married Catherine Aaron, also of Peoria, and a fellow graduate of the law school, shortly thereafter. Following the close of World War II, their children Mark, Ann and Glen were born.

Frank entered Wilson & McIlvaine and joined Philo Gilbert, also a U of I Law School graduate, in the commercial real estate practice, representing among others, Marshall Field & Company. Philo soon turned over Fields to Frank. This was timely for Frank, for shopping centers were in their infancy. Frank developed the first shopping centers in the Chicago area for Fields—some seven in all. The first, Old Orchard, became a prototype. Years later, he converted the Hancock Center, on upper Michigan Avenue, from a rental to a mixed-use condominium. It was again a first and a prototype for followers.

Frank's client list eventually included the Kennedys, who owned the Merchandise Mart, the Field family in its many real estate holdings, the Field Museum, and the McCormicks in the sale and the development of McCormick Ranch north of Phoenix. In his later years of practice, Frank's most important client was the Chicago Dock and Canal Trust. William Ogden, the first Mayor of Chicago, purchased fifty acres of land on the north side of the Chicago River and established the Trust to manage those acres. Abraham Lincoln was its first attorney. Frank was its last attorney before the Trust went public.

Frank was a gifted baritone who found joy in singing for public and private audiences throughout his life. He was an expert birder who, in his extensive travels with Catherine in every continent but Antarctica, had seen more than 5,000 species.

Frank is survived by Catherine, his wife of 64 years, his three children, ten grandchildren, and two great-grandchildren. Mark is a gastroenterologist at the University of Wisconsin, and Glen is a minister at the Christ Presbyterian Church in Madison, Wisconsin. Ann is an attorney practicing with Stevens & Lee in Princeton, N.J. His grandchildren include Marnie R. Leavitt, Lisa A. Reichelderfer, James J. Tye, Matthew M. Tye, Abigail T. Vaughn, Caitlin T. Reichelderfer, Molly E. Reichelderfer, Bridget A. Reichelderfer, Graeme D. Blair and Susannah E. Blair. His family is grateful for the care he received from the Plymouth Harbor staff.
